Principal informed the GB members that the information regarding student admissions will be made available to the next meeting. Since students admission process is incomplete. Report on the academic performance of the students is referred to the next meeting for want of non-availability of information like results publication etc.,. Principal and faculty of ASCET are actively involved in the NAAC accreditation preparation. College placement cell has been putting rigorous efforts to invite companies by organizations for on-campus and off campus recruitment of students. HODs of all the departments are advised to encourage their respective faculty to participate in FDPs/workshops/refresher courses so as to enable the faculty to keep acquainted with the latest advances in their subjects. HODs are requested to make students of the respective departments not to involve in ragging activities by taking suitable measures. Physical Education Director is instructed to organize and conduct various sports and games enabling large number of students participate in such activities. HODs are also advised to associate themselves with the college placement officer in organizing industrial visits both for faculty and students.

Principal sought the permission of the GB members for the permission to submit the detailed budget for the financial year 2011-2012 in the next meeting.

Details of various activities would be presented in the next GB meeting.

**13. Any other items**


No additional Item was brought for discussion.
