##### **2.1 Student admissions for the academic year 2012-13 as per approved intake**

**2.2 Academic performance of students**

I B.Tech students of ASCET stood 1<sup>st</sup> among all JNTUA-Anantapur affiliated engineering colleges by securing highest pass percentage in 1<sup>st</sup> B.Tech results and the overall pass percentage of IV<sup>th</sup> B.Tech students made ASCET to stand one among Top 5 colleges.

- Ms.A.Radhika of I<sup>st</sup> B.Tech ECE topped the results in JNTUA-Anantapur with 94.20%.
- 10 of Ist B.Tech(ECE) and 4 of Ist B.Tech(CSE) students secured positions among the top twenty of each branch in the university results.

### **16. Suggestions & Observations of the Members of the Governing Body**


